



Denver Beer Co. Official Sweepstakes Rules

POP INTO SPRING SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW. ENTRY INTO THE SWEEPSTAKES CONSTITUTES YOUR ACCEPTANCE OF THESE OFFICIAL RULES.

1. Binding Agreement:

To enter the Sweepstakes, you must agree to these Official Sweepstakes Rules. Submission of an entry constitutes your agreement to these rules. You agree to receive email communication from Sponsor, with the ability to opt out later. You may not submit an entry to the Sweepstakes and are not eligible to receive the Prize unless you agree to these Official Rules. These Official Rules form a binding legal agreement between you and Sponsor.

2. Eligibility:

To be eligible to enter the Sweepstakes, you must:

- Be a legal resident of the State of Colorado
- Be twenty-one (21) years of age or older at the time of entry

Receive one (1) additional entry for each Rocky Mountain Pilsner (draft or 6-pack) purchased during the sweepstakes period.

Void outside of Colorado and where prohibited by law. Promotion is subject to all applicable federal, Colorado state, and local laws and regulations. Additional terms, eligibility requirements, and restrictions may apply.

Begins at 12:00 AM MST on March 9 and ends at 11:59 PM MST on April 30 (“Sweepstakes Period”).

Sponsor reserves the right to shorten or extend the Sweepstakes Period at its sole discretion. Sponsor’s computer is the official timekeeping device for these Sweepstakes.

5. How to Enter:

Automated entries are prohibited and any use of automated devices will cause disqualification. Entrants may not enter with multiple email addresses nor use any device or artifice to enter multiple times or as multiple entrants. Multiple entrants are not permitted to share the same email address.

Should multiple users of the same email account enter the Sweepstakes and a dispute arise regarding the identity of the entrant, the authorized account holder of said email account at the time of entry will be considered the entrant and must comply with these Official Rules.



You may enter by:

- Visiting the official Sweepstakes landing page during the Sweepstakes Period and submitting a completed entry form.
- Tag a friend in the comments of the designated Sweepstakes post and repost or reshare the identified social media post for additional entries. To be valid, participants must also submit an entry through the official Sweepstakes landing page during the Sweepstakes Period. Social media actions alone do not constitute a complete entry.

6. Sweepstakes Drawing:

Odds of winning depend on the number of eligible entries received.

7. Winner Notification:

The winner will be notified via the email address provided at entry and must respond within forty-eight (48) hours. Failure to respond may result in forfeiture.

The potential winner may be required to complete, sign, and return an affidavit of eligibility, liability release, and publicity release within three (3) days of prize acceptance.

If the winner fails to comply with these requirements, Sponsor may select an alternate winner.
